Let me once again express its utmost importance of Your daily activities and appreciate Your team's commitment to tackle extra emergency situation in regards with humanitarian consequences of unjustified wide-scale russia's military aggression against Ukraine.

In this context, I would like to convey a request from the Kyiv City Military Administration, which includes items for effective protection of the Kyiv population from further russian aggressive stage. Dear Sirs!

Kyiv City Military Administration, according to the difficult situation caused by the military aggression of the Russian Federation, asks for humanitarian aid to ensure the protection of the population of Kyiv.

Today there are urgent need for the following material resources:

- personal dosimeters - 7000 sets;
- filter gas mask with a combined filter for protection against hazardous chemicals and combat poisons with a bag for transportation (gas masks with panoramic mask type Drager DHS-7000, CM-6 or SGE 4003, which meet ISO 9002 quality standards, and filters to protect against toxic warfare agents, radioactive, hazardous chemical and biological substances that meet the European standard EN141 (DSTU EN-14387 Ukr.) and have 3 efficiency classes - 7000 sets;
- suits of chemical protection for protection against hazardous chemicals, radioactive and biological substances complete with protective boots and gloves (such as a special individual set of radiation chemical protection of the rescuer (protective clothing) SSHKZR-II) - 7000 sets;
- dosimeter - radiometer - 1000 sets;
- respirators for protection of respiratory organs from radioactive dust (type FFP1, FFP2) - 5,000,000 units;
- decontamination cabin for special treatment (decontamination) of rescuers one-segment (type DK-1 complete with open and closed tanks - 500 liters., pumps for water collection and supply, pump for deployment) - 200 sets;
- kit for mass decontamination (special treatment) of the population during emergencies (80 people per hour) - 10 kits ([https://www.hdtglobal.com/product/company-mass-casualty-decontamination system/](https://www.hdtglobal.com/product/company-mass-casualty-decontamination-system/));



- filters combined for filter gas masks - 100,000 sets;
- portable, knapsack decontamination system type "Light Decontamination System ATM-10" - 360 sets.
- decontamination glove type DECON MITT - 20,000 units;
- device for detection and identification of radionuclides - 50 sets;
- portable chemical detector of military and industrial chemicals such as ChemPro100i - 100 sets;
- identifier of chemicals such as HazMatID ELITE - 20 sets;
- portable radio stations - 1000 pieces;
- lighting masts - 40 pieces;
- diesel generator - 180 pieces;
- individual first aid kits - 1700000 pieces;
- red and white signal tape - 5000 meters;
- tablets of potassium iodide, iodine solution 5%, lugol solution 5% - for 7 days per 1,700,000 population.
